

### **ED OLOWO-OKERE**

Global Director, Governance Global Practice, The World Bank Group. Ed a Nigerian national with three decades of experience working on governance issues around the world, leads the World Bank's Governance Global Practice. The Global Practice is focused on helping countries build capable, effective, accountable, transparent, and inclusive institutions that deliver citizen-centric services, facilitate private-sector growth, and improve trust in Government. The Global Practice provides expertise on governance issues, ranging from public financial management, domestic resource mobilization, state-owned enterprises reform/ corporate governance, public institutions reform, decentralization/subnational governance to public procurement, anti-corruption policies, fiduciary assurance, political economy analysis and GovTech (i.e. leveraging technology to modernize the public sector and improve service delivery to citizens and business, and increase efficiency, transparency and accountability). Prior to joining the OBR, Richard was Director of Fiscal Policy at HM Treasury in London and a Division Chief in the Fiscal Affairs Department at the IMF in Washington.



### LAILA SBAIH

Mrs. Sbaih is a Palestinian leader woman known for her long extensive experience in the field of sustainability and inclusive development. Mrs. Sbaih's wide experience in core sustainability topics comes in her capacity as both a civil engineer practitioner and as a General Director of International relations at MoF. She held many positions in local development planning where she had spent years of direct leadership in the frontlines of infrastructure - energy, water, and agricultural programs. Mrs. Sbaih then continued her career path in inclusive development through public finance at the central government level. In 2012, the Palestinian ministry of finance appointed her to lead the International Relations and Projects Directorate where reform discussions prevailed the stake of bilateral agenda between MoF and International partners. With this assignment, Mr. Sbaih has been known as one of few women who led the MOF at such a senior PFM reforms level. Mr. Sbaih had proven remarkable achievements in introducing and monitoring PFM reform programs including negotiating and co-designing strategic reform initiatives that had long-lasting reform influence on the government's inclusive development agenda.



### **SRINIVAS GURAZADA**

Srinivas Gurazada (Srini), an Indian national with three decades of experience working on governance and public financial management around the world, is the Head of PEFA Secretariat and the Global Lead Public Financial Management.

Srini works on governance issues, ranging from government budget reforms, public financial management, domestic resource mobilization, public sector financial reporting (IPSAS), Governance in Sectors (specifically health & education) etc , to anti-corruption policies, control & oversight (Internal Audit, Supreme Auditing Institutions etc) and use of information technology for modernizing public sector. Pekka Morén is (since 2020) the Special Representative of Finance Minister on Climate Action, acting full time as a Co-Chair of the Coalition of Finance Ministers for Climate Action as the Sherpa of Finance Minister. In this capacity, he represents the Minister at high-level events and re-ports to the Minister. He also represents (since 2016) Finland at the Nordic Investment Bank as Member of the Board of Directors.

Previously, he acted as the Director on International Financial Affairs (2016-2020) and the Director in charge of Euro Area Stability (2011-2016) at the Finance Ministry. Prior to this, he was a Special Advisor on EU Financial Stability and Crisis Management issues, during the early stages of the in-ternational financial crisis (2008-2010). He served as Economist at the European Commission in Brussels, at the Secretariat of Economic and Financial Committee, Economic Policy Committee and Eurogroup between 2003 and 2008. Prior to this, he acted as the Director responsible for the Stabil-ity of the Financial Markets (2001-2003) at the Finance Ministry. He holds a Master's Degree (1995) in Social Sciences (Economics) at the University of Helsinki. He studied Economics at the University of Edinburgh in 1991-1992.

The Public Expenditure and Financial Accountability (PEFA) program was initiated in 2001 by seven international development partners: The European Commission, International Monetary Fund, World Bank, and the governments of France, Norway, Switzerland, and the United Kingdom. PEFA began as a means to harmonize assessment of PFM across the partner organizations. It subsequently established a standard methodology for PFM diagnostic assessments, the PEFA framework. Since 2005, PEFA assessment framework has been used in more than 155 countries with over 700 assessment reports that have helped diagnose the strengths and weaknesses of the PFM systems and help plan PFM improvements. In 2019, the Ministries of Finance of the Slovak Republic and the Grand Duchy of Luxembourg became new partners of the program.

The goals of the PEFA Program are to strengthen capacities to assess the status of country PFM systems and develop a practical sequence of reform and capacity development actions, in a manner that:

- Encourages country ownership;
- Reduces the transaction costs to countries;
- Enhances donor harmonization;
- Allows monitoring of progress of country PFM performance over time;
- Better addresses developmental and fiduciary concerns;
- Leads to improved impact of reform
